COMMENTS BY TRUTEES

Board members welcomed everyone back from the winter break and wished all a Happy New Year.

Trustee Pacheco announced that she attended a meeting of the Rio Hondo Over-Site Bond Committee. Trustee Pacheco represents the district on this committee. According to Ms. Pacheco, Rio Hondo committed to continue collaboration with the South Whittier School District.

Trustee Baird announced that she will seek re-election to the Board of Trustees and looks forward to it. Mrs. Baird added that she enjoys being a Trustee.

COMMENTS BY TRUSTEES

Trustee Macias said she appreciates receiving invitations to the various school events in a timely fashion. It makes it easier for Trustees to attend when events can be scheduled on their calendars ahead of time. Mrs. Macias attended the Loma Vista School Holiday Program adding the children and their performance was delightful. She also attended the Graves Middle School Holiday Program and noticed that the band is not very large in numbers of participating students. Mrs. Macias discussed zero period classes at GMS and said she would like to see zero period be reinstated at GMS.

Trustee Stys attended the CSBA Annual Education Conference in December saying that Board members come away very well versed in education matters as they attend many interesting sessions conducted by excellent and informative speakers.

Gail Baxter, Superintendent, attended the CSBA Annual Education Conference and said there were many general sessions with good information provided.

Mrs. Baxter commented on how well the first set of parent conferences went using the new Standards Based Report Cards. There were many people involved in preparing these report cards, the committee who developed the report cards, the school secretaries who had to make sure they were put into the system, and teachers who had to organize them and present them to the parent. Parent conferences were a professional development session for the parents as they learned how to interpret the new report cards. Mrs. Baxter thanked all staff profoundly who participated in the process. The updating of report cards was long overdue as they had not been updated in over 30 years. The process was a success as there were no parent complaints, concerns or questions about the new report card system.

The Superintendent, Administrators and Association Presidents will attend a Governor's Budget Workshop sponsored by School Services of California tomorrow. The group will get more information on the Governor's 2015-2016 Budget proposals. Generally, the information is very positive for education, revenues are higher than anticipated. The Governor wants LCFF to be fully implemented during his term and is proposing increased revenues for education, has promised no more deferrals, districts will get their money on time and is looking at increasing COLAs in categoricals not under LCFF (this would include special education, nutrition programs, Foster Youth). Also included is more revenues for

declining school buildings. The South Whittier School District will conduct a Facilities Use Study. Facilities in the District are in need of repair. The District will also review Prop 39 as a way to generate energy conservation dollars. In order to continue the District needs to develop a plan this year that will lead the District in ways of conserving energy. In further discussion, Mrs. Baxter told the Board they will receive a sample resolution that CSBA recommends, asking that the CAP on the 3% limit on reserves be removed. Many districts have adopted this resolution.

Superintendent Baxter reminded everyone that the South Whittier Community Education Foundation will sponsor a "Pancake Breakfast" on January 31st, here at the District Office. All are encouraged to attend.
