SCHOOL PRESENTATION

Graves Middle School: "Come See the Difference at Graves Middle School" - Principal, Dr. Matt Fraijo, gave a report on the progress being noticed at Graves Middle School. Dr. Fraijo's belief is that a loving and respectful environment must be created for students and they in turn will be respectful. New procedures have been initiated at GMS such as all students must wear identification badges at all times while on campus as this controls behavior. Rewards are earned by the students and a Student of the Month program has been initiated. Dr. Fraijo's plan consists of four focus points: Instructional emphasis, School wide classroom discipline plans, Program development and marketing and Reducing the number of Interdistrict permits. He expanded the information on each of the four focus points. Dr. Fraijo believes that everyone at GMS must emphasize positive behavior. In addition, an employee Social Committee has been developed and an Employee of the Month is awarded to a deserving employee. He emphasizes to the teaching staff that they must have control of their classroom and promote academic enjoyment. With the AVID program at GMS, Dr. Fraijo believes that our middle school has the ability to become a demonstration school. Dr. Fraijo sees continuing improvement with students and enthusiastically supports a respectful and loving school environment.
