PUBLIC COMMENTS Mr. Frias addressed the Board of Trustees with concerns about

using Aeries.net in a classroom setting and not meeting the needs of the teachers. Mr. Frias stated that for the last few years some teachers have been attempting to transition from Easy Grade Pro to Aeries.net. He feels that Aeries.net is designed for administrators and is not teacher friendly. Mr. Frias asked the Board to look into the possibility of incorporating a conversion type software program

that will allow the teachers to continue to use Easy Grade Pro.

Mrs. Baxter welcomed back everyone from vacation. She shared that Mrs. Rojas, Mr. Keriakous and all of the principals were at the Google Summit today and tomorrow in preparation for the new school year. She also shared that we will be refocusing our monthly school reports on students this year and that each site will be selecting students to present to the board that they see as the "Dreamers" of tomorrow.

Mrs. Baxter reported that the state has already started sending out warnings to all school districts in preparation of receiving their test scores this year. In a letter from the CDE it is stated that scores should be arriving about 8 weeks after the close of testing, and that based on trial runs of some test questions in California and other states, many, if not most, students will need to make significant progress to reach the standards set for math and literacy that accompany college and career readiness. In addition, there will be new performance levels and different names for those levels.

Rather than advanced, proficient, basic, below basic, and far below basic, the categories are now standard exceeded, standard met, standard nearly met and standard not met.

Mrs. Baxter also reported that Presbyterian Intercommunity Hospital will be discontinuing services for our families through the Care Force One van due to budget cuts. We will still have access to the community resource nurse but services will be greatly decreased. We will be exploring other options to bring much needed health services into our community.

The district will be moving to an electronic agenda, hopefully by September. Mrs. Baxter showed the difference in size between an electronic and paper agenda. The board will receive training on this process over the next two months. Mrs. Baxter shared that the Board will still be responsible for approving all of the same items that they have always approved but the agenda will just be in a different format.
