8. GENERAL

8.1. Resolution No. #16-17-18 - Rescheduling of Governing Board Member Elections from Odd to Even-Year Elections commencing with the 2018 Government Board Election. (Supplement)

SB415, signed into law in 2015, mandates that districts change their governing board elections to even numbered years if voter participation is substantially lower in odd numbered years. This is the case in South Whittier.

The Elections Code allows school districts to consolidate their elections to even-year elections. Currently, the District holds odd-year elections for its membership. This typically results in a lower voter turn-out and constitutes a higher expense to the District than even-year elections.

If the Resolution is approved, this would commence the process for moving elections for governing board members to even years, starting with the 2018 election. If the Resolution is approved, the District would submit a formal request to the Los Angeles County Board of Supervisors asking for approval to move to even year elections. As part of the process, the Los Angeles County Registrar Recorder/County Clerk's office will submit an analysis (of the viability of going to even year elections) and a recommendation to the Los Angeles County Board of Supervisors. The Resolution will then be immediately forwarded to the Board of Supervisors for consideration. Timely submission of the resolution will ensure that the move to even year elections, if approved by the Board of Supervisors, can commence in 2018.

Cancelling the 2017 election means elected officials with expiring terms get to stay in office one more year and face re-election in 2018. The same will happen for members whose term expires in 2019, as their terms will also be extended for one year and they will be on the ballot again in 2020.

As part of the First Interim report, each school district must certify that its financial status is positive, qualified, or negative. Each of these terms is defined below:

- A positive certification means that the district will meet its financial obligations for the current fiscal year and subsequent two years.
- A qualified certification means that the district may not meet its financial obligations for the current fiscal year or two subsequent years.
- A negative certification means that the district will be unable to meet its financial obligations for the remainder of the fiscal year or for the subsequent fiscal year.

As discussed in this report, the South Whittier School District is submitting a positive certification for the 2016-17 First Interim Report.
